
Dear Applicant:

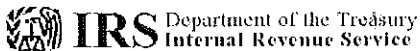
